Again the **Bottling Works**, 426 E. Main Street, Romney is the site for this exhibit/sale. Both framed and 3-D work will be accepted. Gallery space includes the office of Hampshire County Visitors Center and is open Tuesday-Sunday, promising great foot traffic.

A reception and Awards Ceremony is scheduled for the closing, November 6 from 6-7pm, just prior to a concert by the Ensemble of American Balalaika Symphony Orchestra.

ELIGIBILITY: Artists 18 and older are invited to submit up to three original works of art. Artwork must not have been previously entered in a HCAC Fall Show. Sale of artwork is encouraged, a 25% commission will be deducted from all sales.

FEE: HCAC members \$20.00 Non-Members \$25.00 The fee is non-refundable and includes up to 3 pieces.

SPECIFICATIONS: All framed work must be wired and ready for hanging, not to exceed 48" in any direction. Work with glazing must have plexiglass if over 24". Three dimensional art will be mounted on pedestals with a weight limit of 30lbs, or artist may provide display. Size for 3-D pieces must not exceed 48" in any direction. Fiber Art must have sleeve and dowel to hang. Full sized Quilts are permissible.
