The Hampshire County Arts Council invites you to participate in their annual Fall Fine Arts Show which will be held September 2nd - October 14th, 2011. The show will be held at the Bottling Works, 426 E. Main Street, Romney, WV 26757. Both framed and 3-D work will be accepted. Gallery space includes the office of the Hampshire County Visitors Center and is open Tuesday-Sunday, promising great foot traffic.

A reception and Awards Ceremony is scheduled on Friday, September 30th from 6:00pm-7:00pm just prior to a concert by the Paul McKenna Band.

Eligibility: Artists 18 and older are invited to submit up to three original works of art. Artwork must not have been previously entered in a HCAC Fall Show. Sale of art is encouraged; a 20% commission will be deducted from all sales.

Fees: HCAC members \$20.00; non members \$25.00. This fee is nonrefundable and includes up to 3 pieces.

Specifications: All work must be framed and wired for hanging. **No saw tooth hangers, please!** Work should not exceed 48" in any direction. 3-D work will be mounted on pedestals with a weight limit of 30lbs.

Calendar: All work is to be hand delivered. Work will be received at the Bottling Works on Wednesday, August 31st from 4:00pm-7:00pm and on Thursday, September 1st from 10:00am-1:00pm. Hanging and judging scheduled immediately afterward. Work may be picked up at the end of the show on Friday, October, 14th or Saturday, October 15th during Visitor Center hours.

Reception and awards: A reception and awards ceremony will be held on Friday, September 30th from 6:00pm-7:00pm prior to the Paul McKenna Band concert. Award winners will be notified shortly after judging.
